Subject: Enhancement of CCASS and CCMS Report Download

Reference is made to the circular dated 12 December 2024 (PT/OES/CCASS/051/2024) and 19 December 2024 (PT/OES/CCASS/052/2024). Hong Kong Exchanges and Clearing Limited ("HKEX") is pleased to provide comprehensive information regarding the enhancement of Central Clearing and Settlement System ("CCASS") and Common Collateral Management System ("CCMS") Report Download across the Securities and Derivatives Markets (the "Enhancement") as the first service release of Orion Cash Platform ("OCP"), as well as the upgrade of Report Access Platform ("RAP") Phase 2.

The RAP will be enhanced to enable download of CCASS and CCMS reports using the Secure File Transfer Protocol ("SFTP") in mid to late July 2025 (tentative date). By delivering the modernised data transmission solution, it facilitates automated processes and improves operational efficiency. The Enhancement is crucial and compulsory for Participants other than Investor Participants ("Participants") and Designated Banks ("DBs") as the existing report retrieval channel via CCASS Terminal will be replaced by the SFTP before the end of October 2025 (tentative date). The Enhancement and its implementation timeline are subject to regulatory approval.

HKEX is also pleased to announce that the Orion Cash Platform ("OCP") webpage has officially gone live. The new OCP Webpage will provide Participants and DBs with access to OCP project status updates, market documents, and additional information to support your operations. Participants and DBs are encouraged to visit the webpage and utilise the available resources to stay informed about the OCP. The "Enhancement of CCASS and CCMS Report Download - Migration Guide" and the updated "HKSCC Report Access Platform (RAP) Technical Guide" are available on the webpage to assist Participants and DBs in their planning and preparation.

To facilitate a smooth transition of operation in Participants and DBs, an online briefing video will be available on OCP Webpage to provide an overview of the Enhancement starting from 16 April 2025.

Questionnaire

HKEX has published a questionnaire to collect necessary information and understand the arrangements from Participants and DBs for this Enhancement. Participants and DBs are required to complete the questionnaire "Enhancement of CCASS and CCMS Report Download – Questionnaire (HKSCC)" via the "Event" section in Client Connect on or before 30 May 2025.
